Small dice, 6-7 mm, with dark brown colour and intense cocoa smell and flavour.

Characteristics

Decoration with the typical intense brownies flavour. It can be used for plentiful different uses. As a filling in layers by alternating it to gelato (for instance Chocolate or Walnut flavour) also in combination with Nutgel Brownies. As decoration and filling for Frozen Yogurt as well as for many cold process pastry recipes to complete fillings as a garnishing.
