# **Product description**

# Appearance

Straw-white coloured sliding powder, with delicate ricotta smell and typical flavour.

#### Characteristics

The typical flavour of ricotta, is presented in the gelateria world with Gelostella RICOTTA, preparation in powder to be added to the milk base mix with a high content of dehydrated ricotta (first ingredient). The flavour you obtain in the ice cream can be customised depending on the quantities and the kind of mix base used and the ice cream texture becomes creamier and fuller. The product can be used for plentiful purposes in confectionery and cold pastry: excellent to prepare ricotta flavoured desserts and semifreddi, for cheesecake and the typical German Käsekuche cake.

60-70 g per liter of milk base mix.

The ricotta flavoured ice cream can be customised by dusting the ice cream surface with cinnamon in powder or Low-fat Cocoa. Furthermore the product is excellent to customise some typical Sicily flavours such as Cassata Siciliana and Cannolo Siciliano in combination with Gelostella Sicily Fruit Salad to create interesting specialities like "CheeseCake" in combination with Gelostella Mascarpone, "Milk&Honey" in combination with Gelostella Milk&Honig and many others more together with Disaronno Amaretto, Yellow Cream and Sorrento Walnut and many fruit flavours.
