#### Appearance

Orange color semifluid paste, containing roasted peanuts in pieces, with intense toffee aroma and flavor.

#### Characteristic

It is a multipurpose paste, with intense toffee flavor containing abundant salted and roasted peanuts chips, that resembles the taste of some famous snacks.

Special for cold snacks.

It can be used as a variegato, for the preparation of "cremini" by alternating it in layers with gelato, as well as in a variety of cold pastry recipes as a filling and garnishing for gelato soft and frozen yogurt.



### List of ingredients

Refined vegetable fats (sunflower, coconut, cocoa butter, safflower, rice), peanuts in pieces (peanuts, salt), sugar, lactose, white chocolate (sugar, whole milk powder, cocoa butter), whole milk powder, skimmed milk powder, milk fats, flavours (walnut), milk proteins, emulsifier: lecithins (soya); colour: paprika extract.
