Product description

Appearance

Golden yellow paste with small pear cubes.

Characteristics

An innovative product with a high content of small pear cubes (8-10 mm).

Used to prepare pear flavoured ice creams characterised by a fresh pear taste and containing pieces remaining soft in the ice cream. May also be used to decorate and garnish plentiful ice cream flavours (ex. Belle Helene, chocolate, yoghurt, etc.) as well as to prepare or garnish fruit semifreddi, mousses in the tub, single portions in combination with other flavours such as chocolate, white chocolate, etc.



List of ingredients

Pear, glucose-fructose syrup, syrup (sugar, water), flavours, acidifier: citric acid; stabilizer: pectin. May contain: SOYA, MILK, EGGS, ALMONDS, HAZELNUTS, WALNUTS, CASHEW NUTS, PISTACHIOS, PEANUT.

Container: polypropylene bucket Size: diameter 215 mm; height 113 mm

Net weight: 3 kg

Dose and use instructions

180-200 g per litre of fruit base mix with water, made for example with Cremante 50, or with the same dosing, added to a water-milk mixture for a creamier ice cream.

If you wish to use pear pieces, you can slightly drain the product. The syrup you get may be used in the ice cream mix.

Mix well before use.

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package
